CHAPTER DECIDES TO WITHDRAW HOSTING 2004 SUMMER NATIONAL MEETING

On Friday September 13th, fourteen members including all but one board member met in Pierre to discuss chapter plans for hosting the 2004 summer national meeting. This was to have been a planning meeting for 2004, but communication received in the previous week from the national organization changed the discussion.

District VI Vice President John Frome informed the SD chapter that the Executive Council approved a budget that will not include financial support for future summer meetings. Some reasons for the national position include:

- An anticipated current budget shortfall
- A recent charge from the management company handling the national administrative duties for the national had already split net profit with the Iowa chapter
- A member survey completed 2-3 years ago did not show strong support for continuation of a summer national meeting.



Visits with the national office indicated that a chapter hosting a national meeting would have complete financial control (rewards, risks, sponsorships). Most members present felt the risks outweighed the potential rewards and did not see offsetting benefits. After considerable discussion and debate, the members voted to withdraw from hosting the 2004 Summer National meeting.

During our brainstorming discussion and debate, an alternative concept for a National Summer Meeting was proposed. The details of this concept are outlined in a letter from the North Dakota and Nebraska Chapter Presidents. A copy of this letter is included with this newsletter publication.
