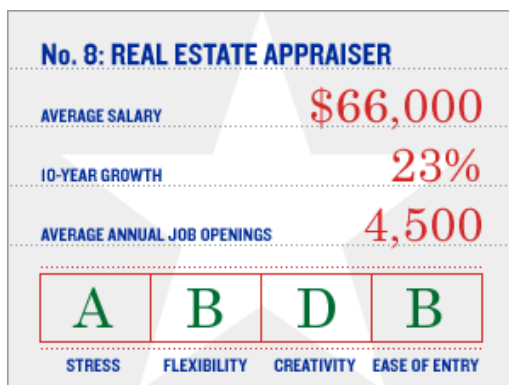

CHAPTER AWARDS ACORN SCHOLARSHIP AT SDSU

Members Brian Gatzke and Paul Reisch represented the chapter at the April 5th Ag-Bio Scholarship Banquet at the Brookings Inn.

Becky Lambert, a Doland High School graduate, was announced as the recipient of the chapter's \$600 scholarship for the 2006-07 academic year.

Becky was chosen when SDSU Relationships Committee members Paul Reisch, Jim Dunlap, and Jim Hollenbeck interviewed three well qualified candidates on March 21st.



The candidate pool represented General Ag, Ag Economics, and Ag Education majors and the locations of Columbia, SD, Letcher, SD, and Frankfort, SD.

Becky is an Agricultural Education major with a passion for FFA and high school agricultural education. She is interested in incorporating exploration of the appraisal, farm management, and consulting professions into her future high school teaching curriculum. She will be working with SDSU Relationship Committee members to accomplish this over the next several months.

The scholarship was created to develop and support student interest in the rural appraisal, farm management, and agricultural consulting professions and to encourage students to become American Society of Farm Managers and Rural Appraiser (ASFMRA) chapter members.

Upper level undergraduate students enrolled in the College of Agriculture and Biological Sciences are eligible for the scholarship. A cumulative GPA of 2.5 minimum, or upper half of class ranking, is required – along with a stated interest in considering rural appraisal, farm management, or agricultural consulting as a career. The following preferences are also considered:

- Community service achievements and demonstrated leadership qualities,
- Completion of or current enrollment in the Rural Estate Appraisal course (Econ 373 / Plant Science 373) and / or Farm and Ranch Management course (AgEd 271).
- South Dakota resident,
- Financial need.

The establishment of the scholarship has contributed to a strengthened chapter relationship with SDSU personnel. The scholarship interview process provided interaction of chapter members with SDSU students, who will share those experiences with other students. The process has also served as a catalyst of potential student members in the chapter (see article next page).

CHAPTER BOARD ADOPTS STUDENT MEMBER POLICY

In an April 13th conference call, the chapter board established a student member policy to encourage more involvement and participation of college students in the organization. Catalysts for board action were the national student member dues reduction to \$25 this past year, the chapter's scholarship program, and student interest in membership conveyed to SDSU Relationship Committee member Brian Gatzke at the April 5th Ag-Bio Scholarship Banquet.

Student members are those who are full-time students in accredited high schools or colleges or universities and who are not providing farm and ranch management, agricultural consulting, rural appraisal and/or appraisal review services for a fee or a salary on rural property belonging to others. Students may remain in this classification for one year following graduation.

The chapter policy adopted by the board:

- Scholarship winner - Chapter pays national dues for one year and waives state dues as long as a person meets the national definition of a student member.
- Other students pay national dues. Chapter waives state dues as long as a person meets the national definition of a student member.
- When a person no longer meets the national definition of student member, the individual pays chapter dues of \$25 regardless of member classification. At the national level, the individual pays national dues related to member classification of academic or candidate if they apply. If they do not apply, the individual pays affiliate dues to belong to national or pays only chapter dues as a partner member.

We are hopeful we can announce student members to the chapter in the near future.

There is a special application for student membership. Contact Membership Chair Paul Sickler or SDSU Relationships Committee Chair Paul Reisch for applications and the process to be followed for a student member to join ASFMRA.

TECHNOLOGY ODDS & ENDS - Technology Committee Chair Allan Husby

I thought I would use this month's column as a follow up to the items presented at the February Continuing Ed in Mitchell and list out some sources for GIS Information.

Aerial Maps- The FSA Aerial Map saga continues to have some changes. As those in attendance in Mitchell know, I presented a sample of section maps that would be available in FSA offices which would show CRP acres and easements along with crop and pasture acres. At that time, it was presented that this would only be available on request through SD Info 10 to appraisers. Since then, it has been determined by our State to make this the stocked, black & white map which offices will have available. Our State Staff has just made the judgment that there is nothing so sensitive in this data that it cannot be provided to those that request maps.

My guess is that you will find all different degrees of labeling to maps being stocked by offices until they cycle through the maps already copied to files. You can request a map with all of the labeling if this is needed.

At this time, only one computer per office has the capabilities to print out and edit particular maps. Over the next month or so, all computers in an FSA Office will have what is called "ArcGIS Lite" installed so all computers will have limited capabilities in ArcGIS, including printing out particular section maps. As FSA approaches having these maps being web based, less and less of the maps will be stocked. This is still a few years into the future.

Statement from Mitchell - "Imagery that is used is satellite imagery." "I heard someone from the group make that statement and that actually is false. None of the imagery from APFO that is used by FSA is satellite imagery and is all done by conventional flyover by airplanes using high quality digital cameras. Older imagery has been oriented to location by putting latitude /longitude points on the maps when they are digitized.

The location of the new imagery is actually "satellite guided" in that a series of satellites pinpoint the location of the picture through GPS. I would suspect that all populated area imagery is also conventional flyover imagery to get the high resolution needed. It can be obvious this is what is happening in Google Earth as it is zooming in to particular locations and then it picks up squares of an area that are orthoquad photos of an area. It looks like it is zooming in to a square picture.

Free Viewers and other Internet Sites – I thought I would do some follow up on what is available and how well they work. A main site that Jim Hollenbeck discussed is Agridata Inc. at the site- <http://www.agridatainc.com/>. This is not meant as an ad, but from what I have investigated, is still the best site as far as a package of available mapping combined with topo maps, soils maps, and aerial maps. It is the only site I have found that combines the productivity indexes with soil descriptions. It, of course, has a fee, but is reasonably priced. I would guess that this site and other sites will continue to evolve with more capabilities.

Another site discussed in the March /April – FMRA News was the Web Soil Survey at <http://websoilsurvey.nrcs.usda.gov/app/>. This is a free site and actually navigates somewhat similar to Agridata. The site will also give links to detailed descriptions of each soil. The only drawback is it does not include productivity indexes.

An additional NRCS site includes a listing of productivity indexes for each county. This might vary from those received from Assessors offices because it is updated yearly, but would be consistent if all properties are treated equally. These are located at the site, http://www.sd.nrcs.usda.gov/technical/Nutrient_management.html. They are listed as excel spreadsheets as NRCS crop Yield Tables (East) and (West).

One more NRCS site which we discussed was the NRCS Gateway at <http://datagateway.nrcs.usda.gov/>. I use this site to download various layers, such as imagery, updated CLU layers, and soils to ArcGIS projects and actually works quite well. The data can also be used in free viewers, such as Arc explorer. These viewers, are of course, limited in what data manipulation that can be done. An account needs to be set up to acquire data from this site, but nearly all of the data is free if downloaded from the site.

Jim also did a demonstration of Google Earth and its capabilities. A free version of Google Earth can be downloaded from this site- <http://earth.google.com/>. From this site, select Get Google Earth (free Version). I don't see any appraiser needing to purchase the google Earth plus- \$20, or Pro- \$400 unless they want to get real geeky.

Adding to this topic there are couple of site that are good for measurement and mapping, some not just for appraising but just good general mapping. Those sites are Google Maps- <http://local.google.com/>, and Google Maps Mania Blogspot- <http://www.googlemapsmania.blogspot.com/>. The final site includes one site where it shows how to connect pictures to locations on a map and that picture will pop up when that location is selected., or it will show where all pictures are connected to particular locations. This site has an overwhelming list of uses of Google Maps.

Speaking of pictures and mapping, Jim H sent me a site which references a new camera available by Ricoh which imprints pictures with GPS location. The pictures can then be connected to a map. The site for this camera is <http://www.geospatialexperts.com/ricoh.html>. This also brings up another site with all kinds of technology gadgets- <http://www.geospatialexperts.com/>.

By now, I'm sure I've given you your fill of websites, especially those not real interested in technology items. The information is put out for you to explore and make your own decisions if you think it might help you in your profession.
