After a time of visiting with others as participants were arriving, President Tom Jass welcomed and thanked those in attendance for coming as well as recognizing Monsanto for their sponsorship.

SDSU representatives then conveyed short updates of activities and happenings.

- College of AgBio Associate Dean Don Marshall reported that SDSU exceeded 12,000 enrollment this past year for the first time. The College of AgBio also had a record enrollment of over 2,000. A new Seed Plant is under construction and a new University farm was purchased located northwest of Volga.
- Extension representative Jerry Warmann highlighted a new program of community, leadership, and economic development called Horizons. Horizons is focused to communities of 5,000 or less and attempt to address resource scarcities in housing, healthcare,

- Plant Science representative Gary Lemme stated the improved diverse cropping systems of SD, aid in finding genomics solutions, and sustainability of agriculture. He encouraged participation in the Extension Virtual Coffee Shop (<http://plantsci.sdstate.edu/>) weekly web conferences. May topics included climate projections, determining planting accuracy, and grasshopper outlook. Past topics recorded and available include managing prayer drift/calibration, anthrax/other vaccines for supper pasture, dealing with Mycotoxin contaminated feeds, seed treatment fungicides, soil compaction prevention, considering tile drainage, plant nutrient considerations in a wet spring, beef cattle in mud/wet conditions, and managing spring stored grain.

- Animal & Range Science Department Head Clint Ruskh has been in his position since August 2009. At last Friday's banquet, the department was able to provide \$90,000 in scholarship funding to students. The department has been successful in growing grants with \$1.6 million secured so far in 2010. Animal welfare is an issue on the horizon that will be a future focus of the department.

- Wildlife & Fisheries Department Head David Willise expressed his appreciation for the invitation as he had already gained knowledge in visits prior to the meeting's start regarding the farm management profession. In recent years, the department has grown to be one of the larger in the country with 265 students this past year.

Other universities have moved away from some of the more traditional programs creating a greater demand for SDSU students. Students with masters and PHD degrees haven't had as much problem with placement (state agencies and universities most frequent). Opportunities at the bachelor level are more challenging but recent years have seen significant placement as conservation officers in the western states.

- Economics Department Head Evert Vandersluis reported there were close to 600 students in the department this past year. About 1/3 have the emphasis and in the College of Ag Biowith the other two thirds having the business emphasis is and in the College of Arts & Sciences. There are about 25 students in the masters program. The department has staff active in teaching, research, and extension activities.

As the department assesses curriculum changes, they want such changes to be based upon the strengths already present. An outline for a proposal in real estate and appraisal has been developed and department staff will be visiting with SDSU Relationships Committee members to get their input.

SDSU Relationships Committee Chair Paul Reisch introduced the chapter's 2009-2010 (Kent Buchholz) and 2010-2011 (Maria Skoglund) scholarship winners. He reported that committee members had made presentations about the appraisal/farm management professions, ASFMR, and the chapter SDSU Student Member Scholarship to farm management classes for the first time this past year. He expressed appreciation for the perspective and dimension our academic members bring to our chapter and encouraged other SDSU representatives to consider membership.

Education Chair Jim Hollenbeck communicated plans regarding the 2011 Special Chapter Event (see separate article for details). SDSU representatives responded positively regarding interest in attending.

Burton Pflueger then led a lively and informative discussion on the productivity value assessed valuation for agricultural properties implemented in SD for the 2010 assessments.

Commodity and rent information used in the process comes from USDA Ag Statistics data. The most recent farm bill has caused some problems in accessing data once available. This has resulted in the source of information for data changing to some degree from 2008 to 2009 and again to 2010.

Particular items that surfaced in the discussion included:

- Pasture land values are currently based upon cash rent, but there may be an alternative method offered in the 2011 Legislative Session.
- Productivity is measured based upon a rolling past 8 years, dropping the high and the low. The goal of this is to provide stability to the process regarding production.
- Productivity is measured by county presently, but they are looking at capabilities to focus by township.
- The 6.6% cap rate is mandated and was backed into based upon keeping the program revenue neutral to previous process.
- Management is not to affect the assessment process. This is the basis for using highest and best use of the land and not actual use. The program allows for some exceptions/adjustments such as reanalyzing Class III land that has been under water for more than three years. This also comes into play relative to irrigation, CRP, etc. Burton gave the example of having to develop a hectro land in the county is irrigated. B dry land base for Butte County even though 90% of

Jerry Warmann then shared some thoughts regarding the July 19-24 International Farm Management Congress that both he and Burton Pflueger attended last summer in Bloomington, IL.

The Congress, usually held every two years, began in 1971. Jerry also attended the 1986 session in St Paul, MN. The Congress is held all over the world. Countries holding the event have included United Kingdom, Kenya, New Zealand, Hungary, Brazil, Ireland, and Australia.

The objectives of IFMA congresses are:

- To provide a forum for exchanging ideas, experience and knowledge through presentations and demonstration;
- To learn about the agriculture of the organizing country, including its structure and marketing;
- To stimulate contacts between farmers, teachers, advisors, researchers, policy-makers and

The Congress has had the theme since 1988. Recent themes have included:

- 2002 The Netherlands – “Feed the World – Please the Consumer – Maintain the Environment”
- 2003 Western Australia – “Farming at the Edge”
- 2005 Brazil – “Developing Entrepreneurship Ability to Feed the World in a Sustainable Way”
- 2007 Ireland – “A Vibrant World Economy – The Challenge for Balance”

The 2009 theme was “Agriculture: Food, Fiber and Energy for the Future”.

Each congress lasts 6 days and normally attracts between 250 and 400 participants from all continents. The scientific program is run on 3 days of the congress and includes a mixture of plenary papers with invited speakers, panel sessions and concurrent contributed papers and posters.

One of the main features of each congress is that on two days of the congress delegates have a wide ranging choice of field trips to livestock, arable and horticultural farms, as well as to research, agribusiness and educational facilities in the local area.

Pre- and post-Congress tours, usually of a week's duration, are organized to give participants the opportunity to see much more of the host country's agriculture and heritage than is possible during the 2 days of field trips organized during the Congress.

A comprehensive and diverse partners' program is offered, and a varied and enjoyable social program is also included in each congress.

Specific experiences shared by Jerry and Burton:

- The event has a pomp atmosphere with an opening procession of flag presentations by the countries represented.
- One tour included an Australian man and his 9 year old daughter as participants.
- Visitors from other countries were struck by the tour of an operation where two unrelated families were participating in a joint venture.
- Visitors were also amazed at the distance involved, the size of equipment, and wondered where the livestock are?

The Eighteen Congress (“Thriving in a Global World – Innovation, Co-operation and Leadership”) is currently being planned to be held in Christchurch, New Zealand in March 2011, and the nineteenth in Poland in July 2013.

SD CHAPTER-KJERSTAD MEMBERSHIP SCHOLARSHIP

The scholarship focus:

- A lasting memorial of Jerry's contribution to our chapter.
- A means to generate funds that can allow expansion of chapter support for members in accord with the chapter mission of *Enhancing Our Members' Ability to Succeed in Their Rural & Agriculturally Related Professions!*

Objectives:

1. Encourage potential members to join our chapter and help them with initial ASFMR A education.
2. Encourage members to attend and learn the benefits of the networking and education that take place at national events.
3. Broaden the experience of chapter members, which will in turn, strengthen our chapter member networking opportunities and develop future leadership for the chapter.
4. Encourage members to pursue accreditation and support them in this endeavor.
5. Recognize the member's achievement in gaining his accreditation.
6. Build member loyalty to the chapter.

Funding for this program is handled outside of the normal chapter operating/budgeting process. A separate money market account is dedicated for this program and the scholarships are paid from this account. Chapter fundraising projects and interest accrual on the account pay for the scholarships.

Scholarship opportunities for members under this program include:

- **\$500 scholarship for Leadership Institute attendance** -- Priority for the scholarship - Chapter President, board member, member who has never attended, member who has attended. Interest to be communicated to Chapter President by August 1st.
- **Pay member registration fee for first time national meeting attendance** - The member planning to attend their first national meeting would inform President and Treasurer.
- **\$500 scholarship for first education course that is apart of accreditation track after becoming a new member.** - Member would inform President and Treasurer of intent to attend. Scholarship paid to member upon confirmation of course enrollment and adequate funds. If inadequate funding, will be reimbursed in future when adequate funding secured.
- **\$500 scholarship for accreditation education for those committed to achieving accreditation.** - Any current member can provide written intent for the upcoming calendar year by December 1st to Chapter President. The written intent will convey the member's status regarding educational requirements and his/her personal timeline to achieve completion of educational requirements, demo report, and sitting for the exam. Scholarship approval will be communicated to a member by March 31 of the calendar fiscal year. The member can be paid \$500 toward the cost of a class still needed within 3 years of scholarship approval.
- **Pay for cost of the accrediting exam** - Payable upon application as communicated by member to President and Treasurer. The cost of exam would be paid on a one time only basis.
- **Pay member registration fee when receiving accreditation at national meeting.** The member planning to attend would inform President and Treasurer.

Scholarships related to accreditation address only accreditation per member. I.E. - Would not cover ARA, AFM, RPRA and/or AACall for one member over time. The Kjerstad Member Scholarship Committee will administer the scholarship. Committee members are President, President-Elect, Treasurer, and one at large member appointed by the President. The at large member is appointed at the beginning of each president's new term.
