SOUTH DAKOTA CHAPTER IN RUNNING FOR 2004 MEMBERSHIP INCENTIVE

The National Membership Incentive Program rewards the five chapters that have recruited the largest number of new members (by percentage of total chapter membership) with a complimentary 'member' registration to the annual meeting. The spirit of the program is to have a new member or first time attendee participate in an annual meeting. 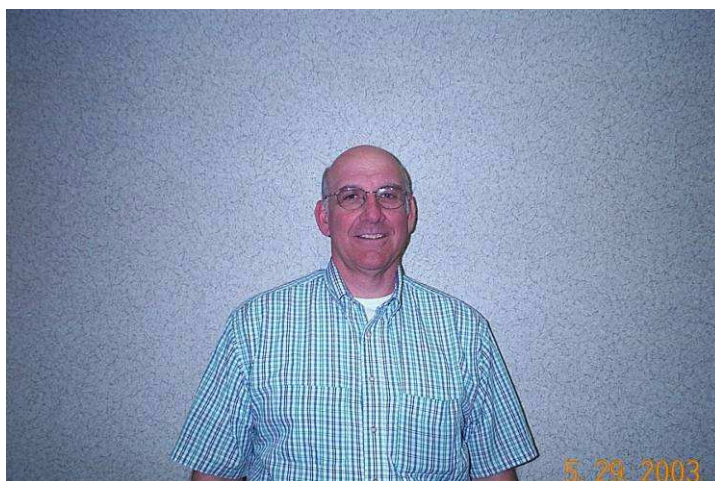

Describe your experience and education related to the property professional field (appraisal, farm management, consulting, academic relation).
