- National Meeting Activities
 - O 2004 Annual Meeting was held in Sacramento. Dr. John Cole and Dr. Larry Janssen were honored along with Dr. Bruce Johnson from the University of Nebraska-Lincoln as recipients of the Gold Quill Award. The Gold Quill Award is awarded each year to the authors of the most outstanding article published during the year in the *Journal of the American Society of Farm Managers and Rural Appraisers*. The three individuals coauthored "Equity and Risk Associated with Share and Cash Leasing: A Nebraska and South Dakota Case Study".  - 2005 national meeting will be held in Austin, TX on October 6-8. There will be no 2006 meeting with the next annual meeting a joint session in February 2007 with ASAC (American Society of Agricultural Consultants and NAICC (National Association of Independent Crop Consultants) in Atlanta, GA.
 - O The National ASFMRA and Illinois chapter will jointly host the 2009 International Farm Management Congress from July 18-25 in Bloomington, IL. This Congress is held every two years and will be in Brazil in 2005 and in Ireland in 2007. The Congress consists of about two days of agricultural tours and about two days of educational sessions, white paper presentations and business.
- Membership The chapter now has just over fifty members and is always looking for additional members including academic members.

Larry Janssen and Doug Malo updated those in attendance on the SDSU appraisal class just completed spring semester of 2005. Paul Reisch spoke to the class regarding appraisal profession as a career and from a lending perspective. The course will be offered again in the spring of 2007.

Those in attendance then listened to a very interesting power point presentation from Kenneth Rutledge, President and CEO, of Dakota Turkey Growers, LLC. See related article.

The meeting concluded with College of Ag Bio Dean Gary Lemme thanking the chapter for offering this on campus opportunity to interact and learn with related professionals.

The event was successful in improving public relations and sharing knowledge on how various SDSU extension and academic personnel can interact with our members and contribute in the future to our achieving our chapter mission through education and networking.



BREAKFAST MEETING ATTENDEES LEARN ABOUT DAKOTA TURKEY GROWERS

Kenneth Rutledge, President and CEO, of Dakota Turkey Growers, LLC presented a very interesting power point presentation at the recent May 20th SDSU Breakfast Meeting. Ken has 32 years experience in the poultry industry, most recently President of Iowa Turkey Growers prior to his current position.

Dakota Turkey Growers was formed out of necessity by 44 growers (Hutterite Colonies and one independent grower) from South Dakota, Minnesota, and North Dakota because of inadequate return for the \$120 million investment in turkey grower facilities. Studies in 2001 thru 2003 led to the

decision to build a new modern turkey processing facility in Huron.





Both Aberdeen and Huron offered good financial packages for the plant. Factors in choosing Huron included biddable power between NWPS and Dakota Energy, meatpacking history, cultural diversity, and positive attitude.

The last ground up processing plant built in the United States was in 1985. This modern \$45 million plant will open in January 2006. It will include a 150,000 sq. ft. plant and 20,000 sq. ft. office building on 110 acres. Future plans include a convenience mart and truck stop.

The plant will have a safety focus and points of differentiation include:

- o Landscaping no trees
- Gas stunning
- Scald and vacuum systems
- Product handling
- o Unique antimicrobial interventions
- o Positive air movement
- Lighting systems
- Segregated Raw & Cooked Areas
- Segregated Slice Rooms
- o Latest Equipment with ease of cleaning incorporated
- Automatic boot and hand washes
- Food safety training and certification

When the plant opens, there will be one shift with a 4 million bird capacity. Two shifts are projected by 2009 with an 8.5 million bird capacity. It will involve deboning processes and slicing machines on the 40 lb. tom turkeys with no whole turkeys. The plant will have 390 employees at start up with a \$12 million payroll. When at full production, there will be 1,000 employees with a \$30 million payroll.

Growers will realize value added income thru the processing plant that will pay competitive prices for the turkeys. The customers are quality producers and this will enhance the company's ability to succeed in co-manufacturing, food service, and niche branding efforts.

ADVISORY BOARD NEWS (COURTESY OF MEMBER JIM HOLLENBECK)

The Advisory Board met in Pierre on Friday May 20th. Highlights:

- Craig Sommers was introduced as new Council Member representing Institutional Appraisers.
- Gary Viken presented outgoing member Jim Hollenbeck with plaque for service.
- Updated on budget.
- Went over 2nd Draft of the SD Appraiser Program Rules (new wording for supervisory appraisers). No changes were recommended.
- An appraiser talked to council about issues concerning supervision of appraisers. The appraiser feels that there are some people acting as supervisors....but not providing supervision. Basically, the so-called supervisor is signing the reports for a fee without any sort of mentoring or supervision of the trainee. The appraiser became aware of this while doing an appraisal for a lender where the lender gave him an appraisal completed by another appraiser. The appraiser would like stricter rules adapted regarding supervision of appraisers. Supervisor's work would need to be reviewed to ensure their competency and credibility to supervisor.

Discussed options for mentoring/supervising. Lynn Heiden's program in Nebraska has been a success.

Council had considerable discussion regarding this whole area of supervision, and difficulty for new appraisers entering the profession. The bottom line is that in order for changes to happen.....appraisers need to start registering complaints and turning in bad appraisers (including the so-called supervisors). Council feels that there are sufficient rules in place...it's a matter of turning in the "problems"....and then enforcing the rules consistently.

- Appraiser Regulatory Network meeting in Omaha July 22, 2005
 - Sherry, Randy attended last year (very good meeting).
 - Those invited are: state regulatory agencies, course providers, appraisal associations

- Went over issue with a compromised electronic signature. Sounds like person allowed someone access to the elec signature, which was used later to sign an appraisal as supervisor. Council didn't feel that there was any problems or issues with rules / regulations as it wouldn't have been a problem if person wouldn't have given access to the signature.

This really highlights the future problems this state is facing.

- Aging appraiser population
- Fewer people coming in to the profession
- Qualifications/Experience is becoming harder to attain
- Fewer options for mentors and supervisors
- Courses becoming less available

This issue will be brought up at the July meeting in Omaha.

CHAPTER PROVIDES COMMITTEE CHAIR PLANNING AND TRAINING

Immediately following the May 20th Breakfast Meeting, nine of sixteen committee chairs were present with the chapter board to discuss committee planning and activation. President Buck presented a committee chair planning guide that addresses:

- Committee functions in relation to chapter mission and operations statement.
- o Specific goals of the committee.
- o Committee member responsibilities.
- o Potential problems and solutions.
- o Materials, supplies, resources needed.
- o Steps to be taken.
- Record of implementation steps.
- o Evaluation at project or year end.

Wade will e-mail the planning document to all committee chairs and requests that committee chairs complete the planning portion and return to him by July 1st. Chairs are encouraged to have conference calls to involve committee members in this process.

Wade also provided committee chairs with a copy of the 2004 summer meeting document to convey the concept and value of a planning document. He also reviewed the conference call guidelines and processes.

The goal is to see that planning is done, goals are set, and follow through is accomplished by involving all committee members. This was the consensus of board discussions last fall as the way to give members ownership in the chapter, keep them involved, and achieve the chapter mission. It was stressed that committee chairs get others involved and not just do everything themselves.

MEMBER PROFILE IS SOCIAL COMMITTEE CO-CHAIR CRAIG SOMMERS

Describe your experience and education related to the property professional field (appraisal, farm management, consulting, academic relation).

I am a staff appraiser with Farm Credit Services of America, in Aberdeen. I've been with FCSA since July of 1986. I graduated from SDSU in May of 1984 with a degree in Ag Business. I started my career with USDA, FmHA in 1984 as a loan officer and started appraisal work that year.

Prior to that, my only experience in appraisal was at SDSU, through Dr. Larry Janssen. I remember trying to have my partner complete all the appraisal portion of Dr. Janssen's class as I figured I'd never be working in that profession!



All of my time is now in the appraisal profession. I complete real estate appraisals and personal property (chattel) appraisals for Farm Credit Services of America. About one third of my work is completing chattel inspections, appraisals and reports. Two thirds of my time is with real estate work and primarily in northeastern South Dakota, in seven counties around Aberdeen. My chattel appraisal work involves more travel time and extends from all of central and eastern South Dakota and into northwestern Iowa. I work with large cattle operations, very large dairy operations and large grain operations.

Describe what has led you to becoming a chapter member of the South Dakota ASFMRA and why you remain a member, if a member for a number of years.
