## MARCH 23<sup>RD</sup> DISTRICT CHAPTER UPDATE CALL

**WELCOME** - Dick Edmunds, ARA, AAC welcomed everyone to the call and took the roll call via Districts. The purpose of these calls is to: 1) Inform everyone what is happening at the National level, challenges being faced, 2) For Chaptersto exchange ideas, discuss what challenges are being faced, and 3) For communication between National and Chapters.

Everyone was encouraged to apply for positions with ASFMRABe involved and active. Due date for applications from interested individuals is April 1<sup>st</sup>. Encouragement membersto apply for this position. Applications are on-line and members are encouraged to contact ASFMRABe in Denver for applications or other information. There are some members who are interested in this position and will be applying. This is very time consuming.

**WHAT IS NEW IN EDUCATION** - National is transitioning core courses to modules. The Income Approach has been approved by AQB and now is out to the States for approval. Cost Approach has been completed and submitted to AQB. The Sales Comparison course is still being developed. All three approaches will be offered this year. ASFMRABe offering more Webinars as a way to offer timely information to the profession members serve. The ACRE Webinar is scheduled for March 31<sup>st</sup>. Another Webinar that is being developed on AMC's and how they can impact the rural appraisal profession.

The Ag Lands in Transition course has just been updated and will be delivered at 2010 Summer Education Week in St. Louis in July. Immediately following that it will be available to the Chapters. The A101 course has been scaled down to three days and now works well as a good introduction to appraisal.

The Ethics Course has been reviewed by the new Ethics Task Force. They have decided that there will be two different courses—one for those that have never taken Ethics which will be four hours long, and one more detailed, information on ASFMRABe, and provide some case studies; these second one will be a refresher course which will be shorter, no longer than three hours. Both will be available in Webinar format. Casestudies will be developed for both appraisal and management issues. The new Ethics Courses should be complete by May 7<sup>th</sup>. Members will be notified if they are due to take Ethics. ASFMRABe can provide a list to Chapters of members in their Chapter who need Ethics. ASFMRABe can be directed to them for a Chapter offering.

ASFMRABe is working now toward providing broker credit where possible on Management/Consulting courses. If a Chapter wants to work with ASFMRABe as a broker credit, the Chapter will be charged the just the amount ASFMRABe is charged to obtain the broker approval.
